The attention of the Deputy Educational Officers, Mandal educational Officers in the district is invited to the references cited above and informed that the Director of School Education AP has declared Single session schools for all classes from I to X from 01.04.2021 with daily timings from 7.45 AM to 12.30 PM followed by midday meal. The last working day shall be till 31.05.2021 in case of I to IX classes and 15.06.2021 in case of X class (including examinations)

During the single session schools time table Learning Acceleration Programme tests shall be continued as per the schedule already given. On every working day concern subject teacher shall conduct the study hour between 1.30 pm to 2.30 pm and test between 2.30 pm to 3.30 pm. Headmaster / Principal shall coordinate the subject teachers to handle the study hour and test hour.

Formative Assessment – II shall be conducted to all classes in the second week of April on the syllabus to be covered upto March 2021 as per the academic calenders issued by the SCERT-AP.

In view of all the above, all the Heads of institutions are instructed to ensure the compliance of the guidelines / Standard Operating Procedures (SOPs) for all activities in the schools issued by the Union / State Govt.s and strictly enforce COVID appropriate behaviour, such as (i) wearing face masks, (ii) hand hygiene and (iii) social distancing among the people.

All the Mandal Educational Officers and Deputy Educational Officers in the district are requested to communicate the same to all the schools of all managements in their jurisdiction and superwise that it shall be implemented without fail.
